Welcome to the Hub Club!

We know how important it is to keep you informed as we transition to our new Early Intervention solution, **EI-Hub**. The Hub Club is a newsletter series that will keep you in the loop on our progress all the way through launch.

What is EI-Hub?



EI-Hub is a new solution designed specifically for the Early Intervention Program (EIP). Once launched, it will allow users across the State to seamlessly manage and record the work they do for children in the EIP. With just a single sign-on through the Health Commerce System (HCS), **EI-Hub** users will be able to capture and report on child information from referral (intake) to transition, including managing provider data, provider management, claims creation, billing, and payments.

With **EI-Hub**, our team is working to improve your experience while also limiting disruption to your work. Wherever possible, the solution will use familiar processes and functions. Additionally, all historical provider and child case management data currently in NYEIS will be converted and migrated to **EI-Hub**, so you won't lose any information relevant to your work.

We look forward to sharing more information about **EI-Hub** with you in the coming months.

What is **EI-Hub** going to look like?

EI-Hub will be accessed through the Health Commerce System (HCS) and will be composed of five modules: Case Management, Fiscal (EI Billing), Provider Management and Enrollment, Service Logging, and Learning Management System (LMS). When will **EI-Hub** be launched?

We expect that the solution will be launched in the second half of 2020.

Onboarding and training will be key to the success of **EI-Hub**. We will be using an online Learning Management System (LMS) to deliver comprehensive training to all users. Training will be available approximately two months prior to the launch of the solution.
